Introduction

- eCDR is an Electronic Complaint Processing System for law enforcement, prosecutors, and other agencies.
- The eCDR system is used to enter and manage Municipal Complaint Summons and Warrants.
- The State Police LiveScan fingerprinting process has been integrated with the eCDR system. This process:
 1. Allows for the positive identification of the defendants
 2. Improves the accuracy of the data
 3. Improves the speed by which law enforcement officers can complete the complaint entry process
 4. Allows a Public Safety Assessment (PSA) to be processed

Introduction

- Allows a judicial officer to authorize law enforcement to issue the complaint in an emergency if the judicial officer is unable to get access to the Internet to issue electronic probable cause.
- Prosecutors will have the ability to review, accept, and decline offenses.
- For additional assistance regarding all applicable laws and guidelines, officers should refer to the New Jersey Code of Criminal Justice, the New Jersey Rules of Court, and the Attorney General's Law Enforcement Charging Manual.


1. Launch an internet browser.
2. Type the following into the address bar :

3. Enter your User ID and Password.

NOTE: Password synchronization (Psynch) required every 90 days.

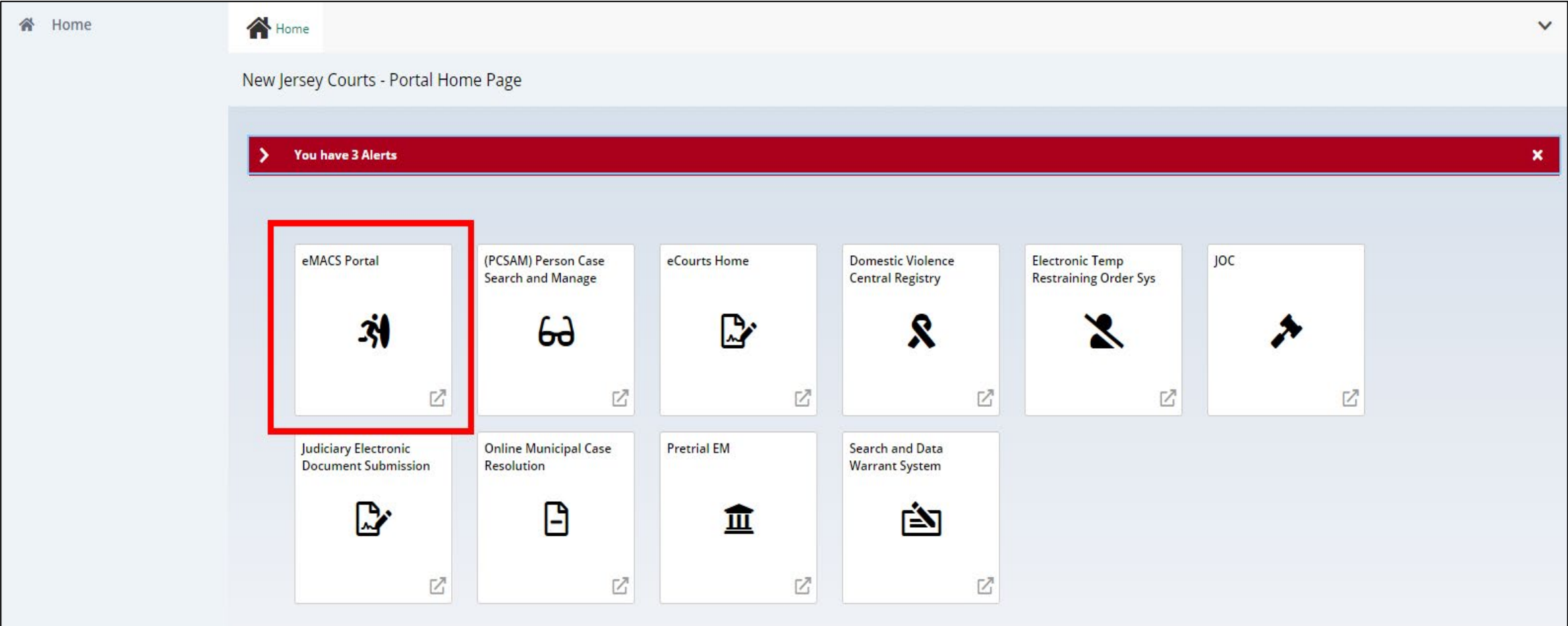
- When a password is reset in either eCDR or AOCTELE, the password will be updated in both applications. If you try to access the Reset Password button and you have not completed the P-Synch process, you will not be able to reset your password.

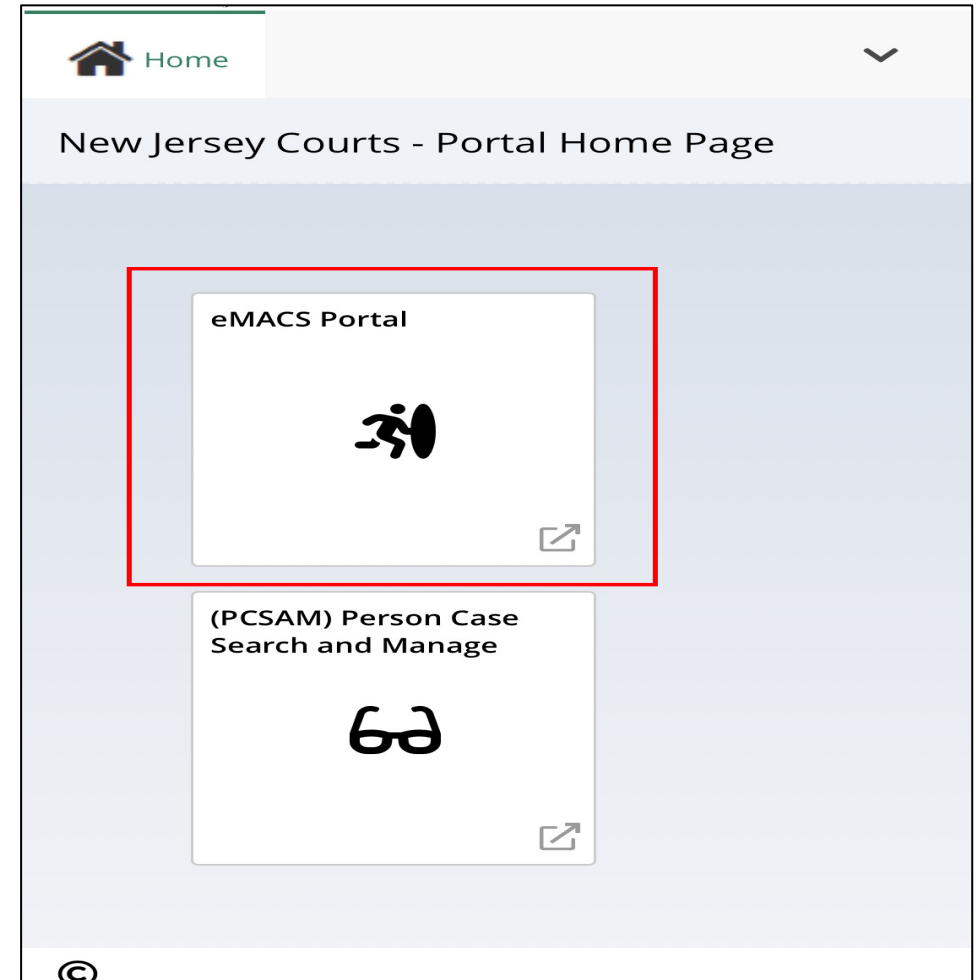
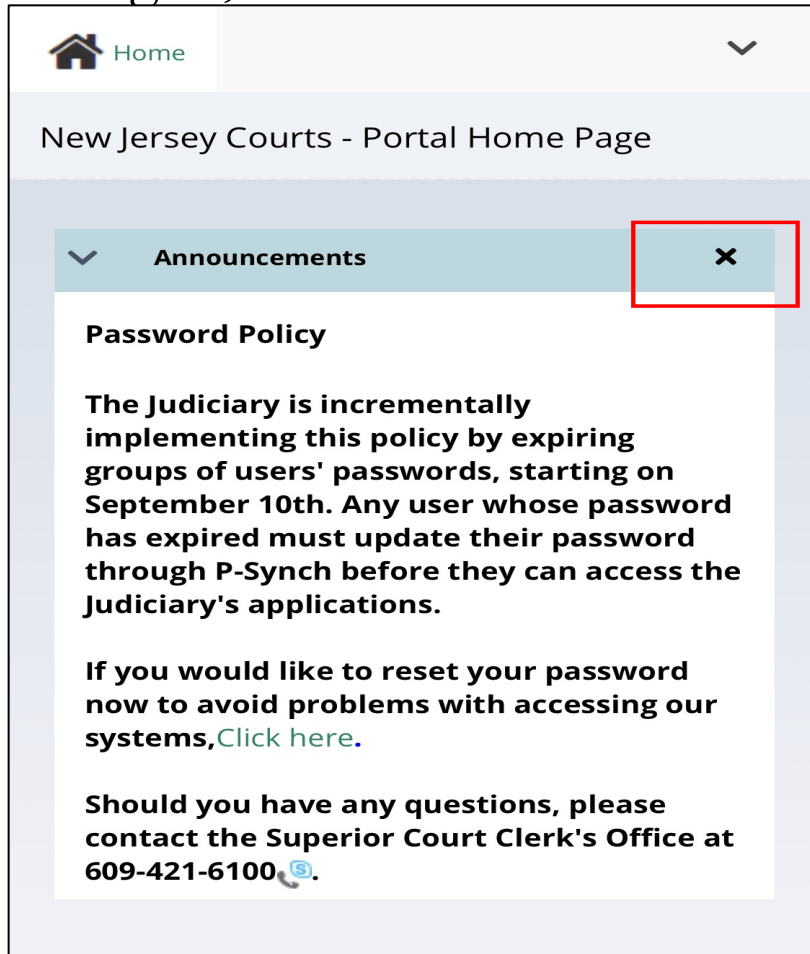

Home Page

- **Complaints tab:** Default tab for managing Municipal Complaints.
- **Announcements** - Includes notifications and upcoming enhancements to the system. This section may be collapsed/expanded by clicking the arrow on the left.
- **Municipal Quick Search** - Retrieves limited case information via a ticket or complaint number.
- **Case Search (Municipal)** - Allows users to retrieve complaint information.
- **My Cases (Municipal)** - List of cases generated in the last seven days. The date range can be modified. Cases will be listed in descending order by Date Created.
- **Review Worklist** - List of cases waiting to be reviewed. A name will display under Reviewer indicating the review has been completed. Actions – Open will not be available while the case is waiting to be reviewed.


Home Page

- **Admin of Oath** - List of Citizen Complaints waiting for a second electronic signature. Cases will be listed in descending order by Date Created.
- **Probable Cause** - List of cases waiting for a probable cause determination by a judicial officer. A judicial officer may authorize law enforcement to activate the complaint when urgent and the judicial officer is unable to get access to the internet to issue electronic probable cause.
- **Home button** – Allows user to navigate back to the home page.
- **My Account** - To navigate other systems, including DVCR, eTRO, Pretrial Electronic Monitoring, and eCourts.
- **Petitions tab:** To search and manage Petitions.

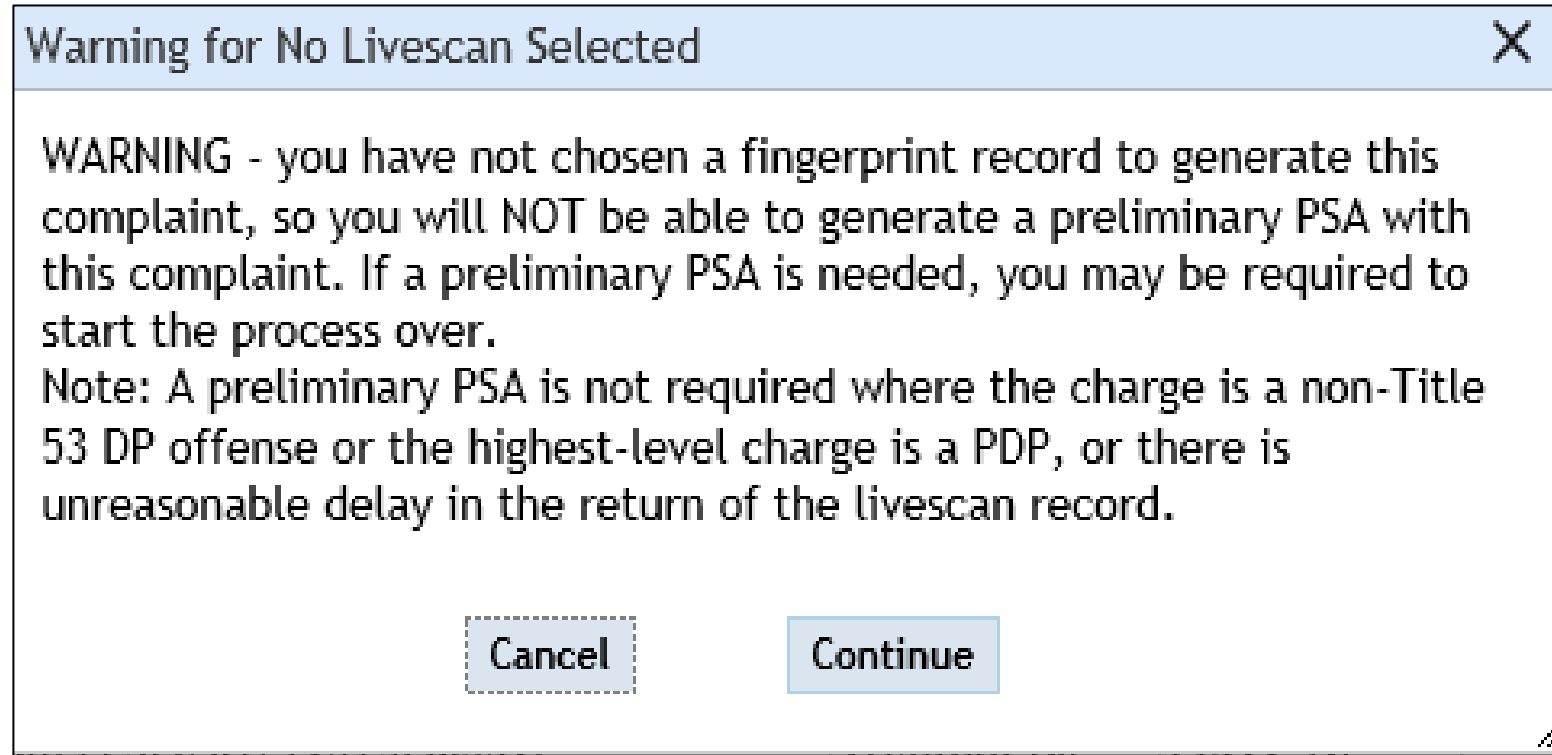

When granted, the complaint may be sealed for 10 days and prosecutors may request an additional 10-day extension.

DCJ Indicator

To identify cases to be prosecuted by the Department of Criminal Justice (DCJ). The selection options for this field are “N” – Not a DCJ case (default), “Y” – Yes, DCJ case, or “D” Direct Presentment – DCJ Case Only.

LiveScan After Complaint Generation

The Livescan Arrest Record should be linked to a complaint after the complaint has been entered into eCDR. This should only be done:

- 1) When an arrest has been made on an outstanding warrant and the defendant must appear at Central 1st Appearance or CJP court, or
- 2) When a summons was issued but the defendant was never fingerprinted and they have appeared at Central 1st Appearance or CJP court, or
- 3) When the Livescan record has been unreasonably delayed and the complaint had to be entered without the Livescan Arrest Record linkage.

- R. 7:2-1(h) – Electronic CDR-2 Warrant
 - Extends the authority to issue telephonic warrants to authorized Court Administrators and Deputies.
 - Replaces the manual telephonic warrant issuance process with a fully electronic process.

The rule provides two ways to activate the warrant in eCDR:

1. Judicial officer accesses eCDR -- determines probable cause and issues the warrant in the system, or
2. If Judicial Officer cannot promptly access eCDR, s/he authorizes the law enforcement officer to “activate” the complaint in eCDR. Note: the issuance is still authorized by the Judicial officer via the telephonic authorization. *

* Includes later validation by the Court.
